POSITION SUMMARY

The heart of The Peregrine Fund's education program is our Interpretive Center in Boise, Idaho, where visitors have the opportunity to meet live raptors from around the world. The Interpretive Center provides a unique experience that engages the public about the importance of raptor conservation. The Raptor Specialist must be a motivated, self-starter that is dedicated to achieving measurable conservation results. She/he is a team-oriented person with a depth of experience with live raptors.

ESSENTIAL FUNCTIONS

The Raptor Specialist will participate in every aspect of care, husbandry, and training of education program raptors. Additionally, the Raptor Specialist will take an active role in education program design and delivery.

RESPONSIBILITIES AND SCOPE

Carry out training and enrichment programs for all education raptors

- Actively participate in a plan to maximize the conservation impact of every education raptor
- Maintain proper husbandry of all bird enclosures and conduct daily wellness checks for all program raptors
- Perform routine maintenance of beaks and talons
- Maintain medical supplies and equipment
- Maintain all equipment used on raptors (Anklets, Jesses, Leashes, etc) and replace as needed
- Assist in assessing and resolving avian health issues
- Utilize safe capture and restraint techniques for small and large raptors
- Prepare food and feed all education birds and maintain proper nutrition
- Maintain paperwork for all education birds
- Participate in the safe transport of raptors to on- and off-site programming
- Modify chamber design as needed
- Participate in the submission and maintenance of permits (USFWS, IDFG, and others as needed)
- Take active role in free-flight bird show
- Conduct daily educational presentations as needed, both with live birds and without
- Train and develop team members and volunteers in bird care and handling
- Collaborate with Peregrine Fund team members to support variety of programs as needed
- Work in a team context to develop short and long term goals for our education program as it fits within the mission of The Peregrine Fund
- Ensure a safe and respectful work environment at all times
- Other duties as assigned

MINIMUM QUALIFICATIONS

- Demonstrated knowledge of raptor care including nutrition, health, and proper husbandry
- Working knowledge of the science of bird behavior, operant learning, positive reinforcement, and enrichment of program raptors
- Demonstrated working knowledge of regulatory requirements and permitting as related to the care and keeping of animals in captivity
- Experience with environmental education
- Experience and confidence with public speaking for all audience sizes and types
- Working knowledge of AZA, USDA, and IAATE standards for animal management and care
- Effective communication skills
- Must possess and maintain a valid driver's license

PREFERRED QUALIFICATIONS

- Bachelor's degree in the biological sciences, wildlife sciences, or a related field
- Experience designing and leading raptor handling classes
- Experience leading presentation workshops
- Experience flying raptors for free-flight programs
- Working knowledge of raptor rehabilitation
- Experience raising raptors from chicks

WORKING CONDITIONS

The Raptor Specialist has frequent close contact with large raptors. Exposure to dust, allergens and hazardous materials is common. This is a physically demanding position requiring good manual dexterity and the physical ability to walk, stand, run, crouch, reach overhead, climb, and move heavy objects. Must be able to work outdoors in all weather conditions. Must be available to work weekends, holidays, and evening events as needed.
